Thank you to our generous donors, volunteers, and agencies for contributing to United Way's impact this past year.

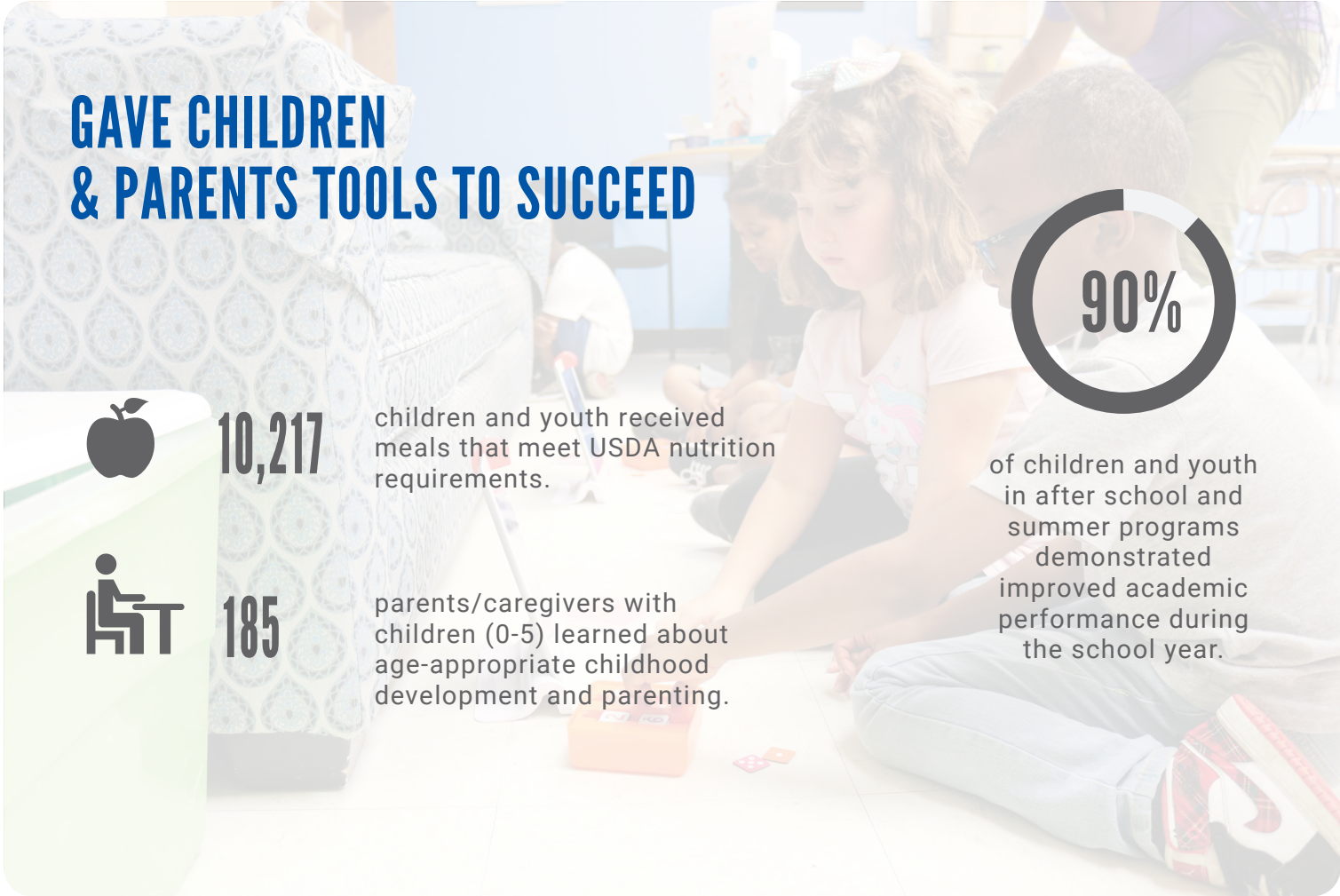

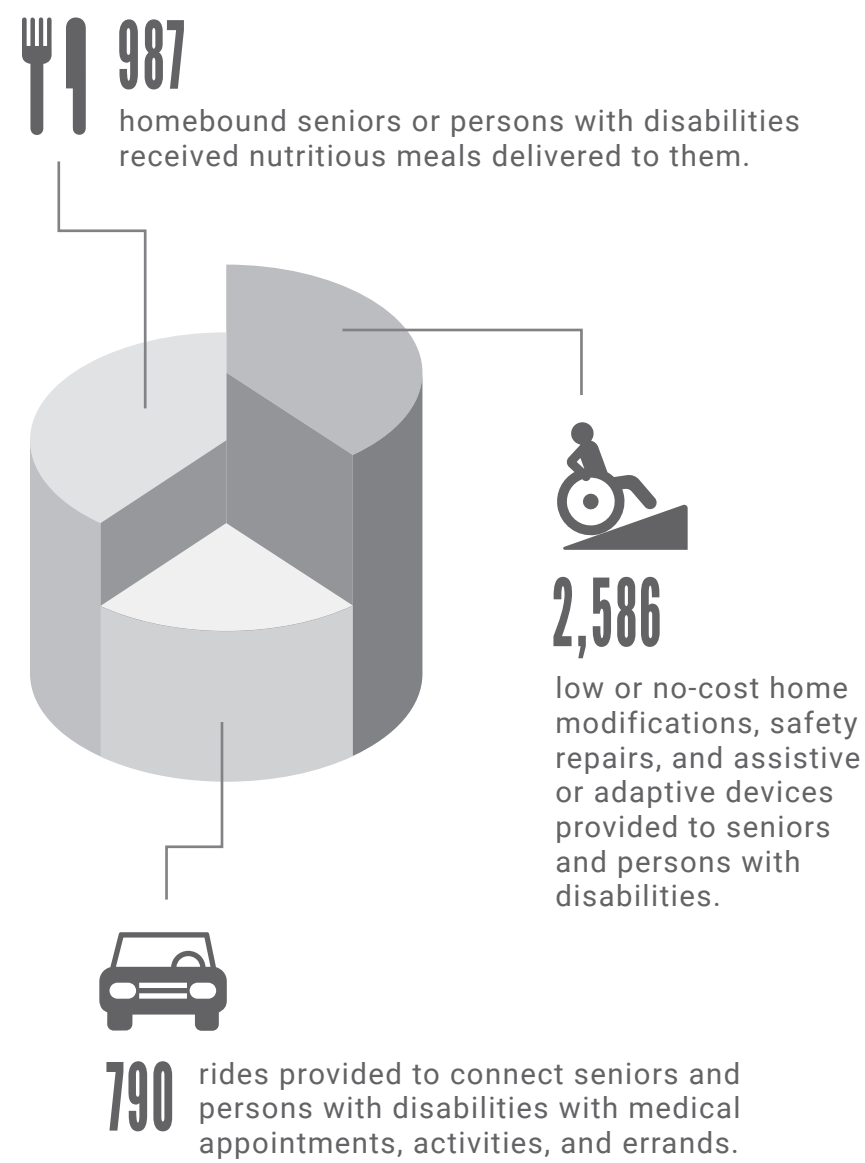

Every rainstorm, Mr. Carter and his wife, who are both in their 70's, would sit and watch the rain as it leaked through their roof - filling buckets in their home in Pooler. Mr. Carter would stay up all night emptying out the rain filled buckets to make sure they did not spill out into the house. Instead of fixing their home's roof that was damaged during Hurricane Matthew, Mr. Carter used what money he had to pay for his wife's heart medicine to help keep her in stable condition.

After calling 211, the Carters finally got the roof they needed and much more. United Way 211 connected with Senior Citizens, Inc. and the Coastal Empire Disaster Recovery Committee to help the Carters qualify for a grant to cover the costs and labor of the roof repair, as well as a repaired entry ramp.

Mr. Carter said in a tone of gratitude,

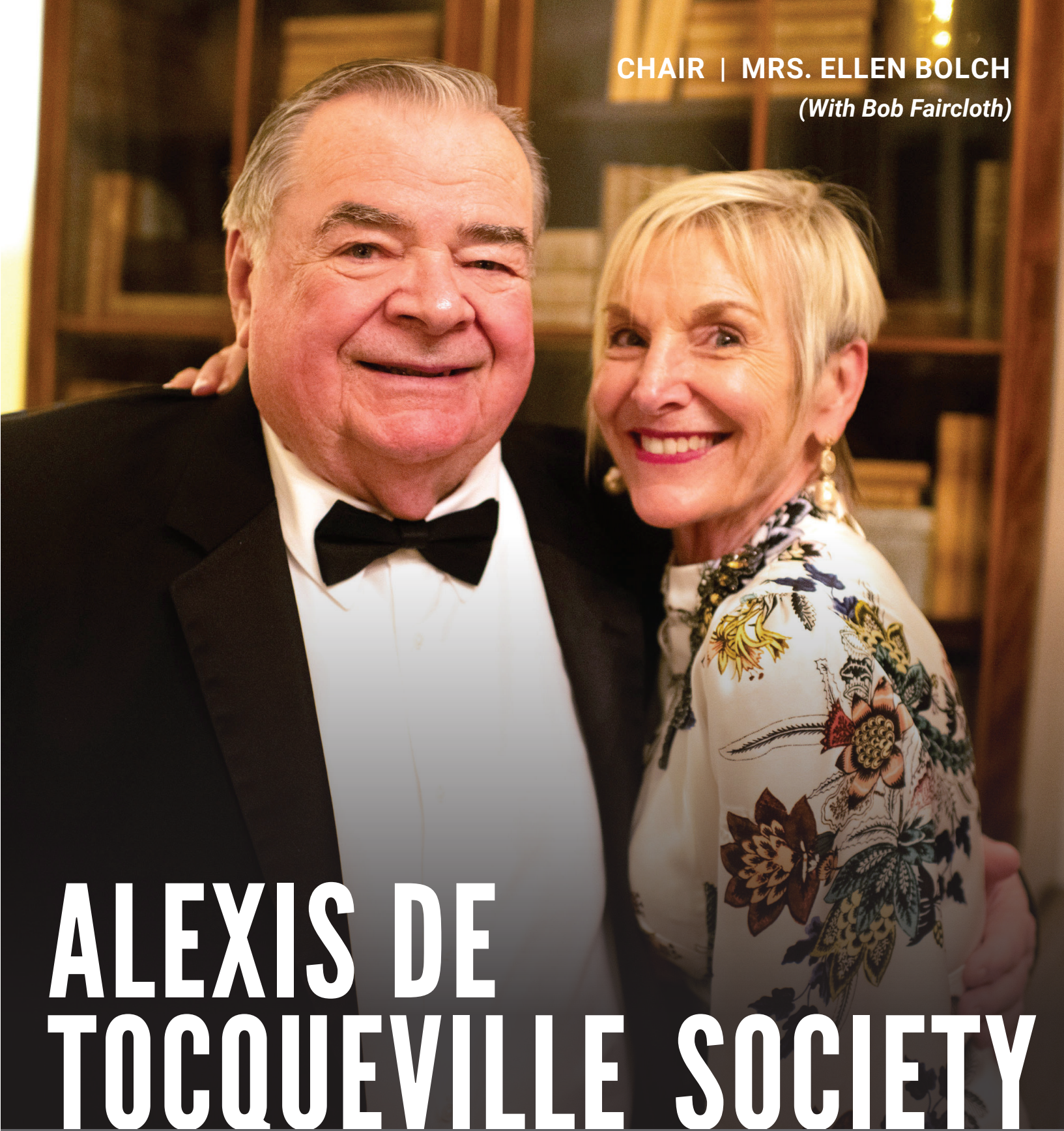

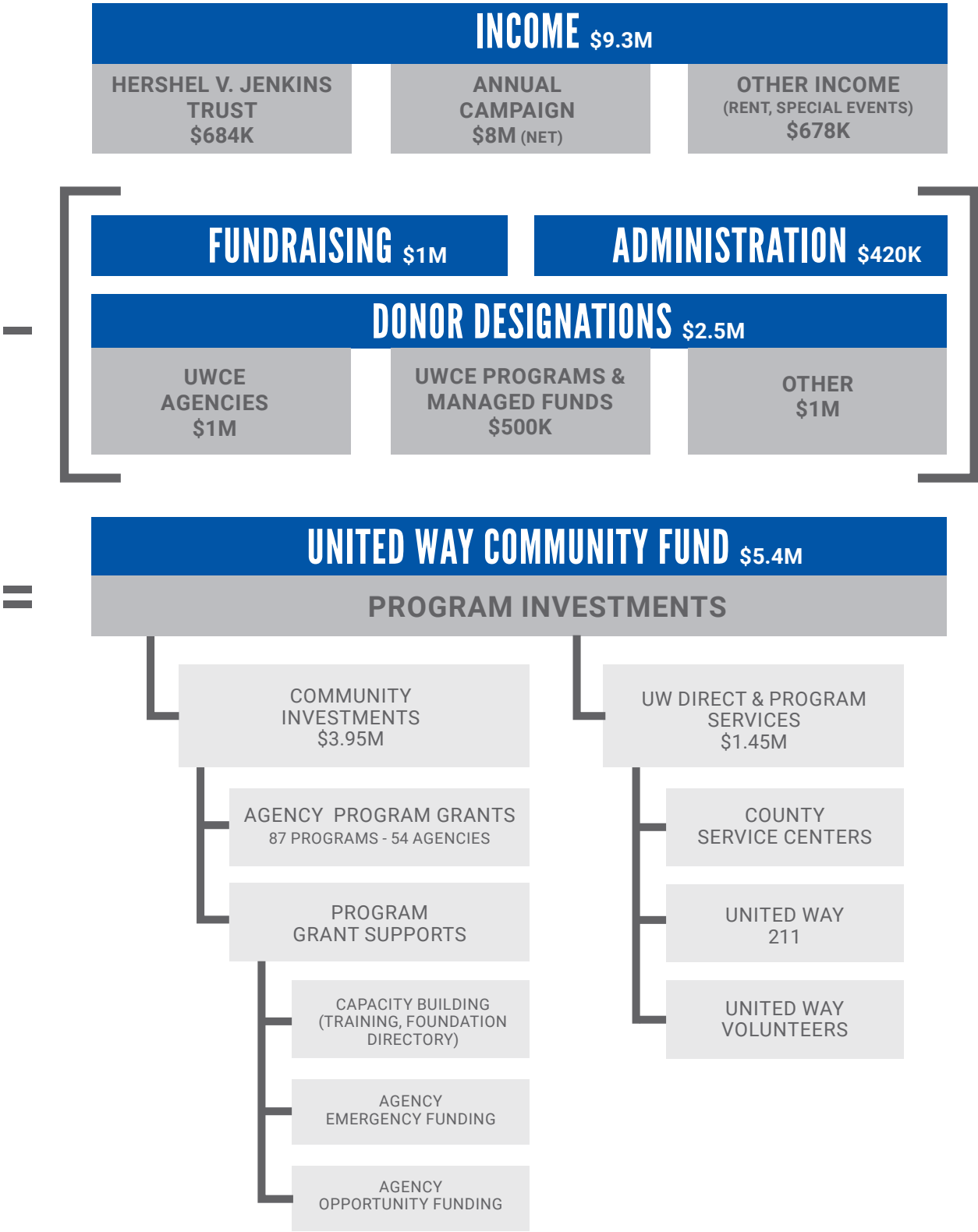
